### What is Measured in Each Performance Area?

#### **Doctors' Communication**

- · Doctors explain things well to members
- How happy members are with their doctors
- Doctors involve the family in their child's care
- · Members who smoke receive help to quit

#### **Access and Preventive Care**

- · Members get the care they need
- · Members get screenings and tests for cancers and illnesses
- Members get the right medicines and services

### **Taking Care of Children**

 Children get regular checkups and important shots that help protect them against serious illness

#### Women's Health

- · Women get tests for breast and cervical cancer to help find these diseases early
- Moms get care before their baby is born to help keep mom and baby healthy
- Moms get care, screenings, and treatment after their baby is born

#### **Behavioral Health**

- Members with behavioral health conditions get the follow-up care and medicines they need
- · Children on antipsychotics get the checkups they need

### **Living With Illness**

 Members living with conditions, like asthma, diabetes, high blood pressure, and COPD, get the care they need by getting tests, checkups, and the right medicine

#### About This Tool

The 2025–2026 Virginia Cardinal Care MCO Consumer Decision Support Tool utilizes results from Healthcare Effectiveness Data and Information Set (HEDIS®) and Consumer Assessment of Healthcare Providers and Systems (CAHPS®). Calendar year 2024 data submitted by the Cardinal Care MCOs were used to derive 2025 reporting year rates. This report was compiled by Health Services Advisory Group, Inc. (HSAG) in collaboration with the Department of Medical Assistance Services (DMAS).

#### About the Accreditation Levels

Accreditation levels as of August 2025 are based on compliance with the National Committee for Quality Assurance's (NCQA's) rigorous requirements and the MCOs performance on HEDIS® measures. The highest level of accreditation an MCO can receive is Accredited, followed by Provisional.
